Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Applicability. Form HUD-50075-ST is to be completed annually by **STANDARD PHAs or TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

The units are located in Ridgely and were deemed structurally unsound.</p> <p>In the ongoing efforts to revitalize low-income properties and update units with modern amenities, apartments will be taken out of occupancy with HUD approval for renovations in Phase 3 in the Walker Court development.</p> <p>Dyersburg Housing Authority will seek applicable grant funding that will be beneficial to the residents that are served and the low-income housing properties.</p>

B.5	<p>Progress Report.</p> <p>Provide a description of the PHA's progress in meeting its Mission and Goals described in the PHA 5-Year and Annual Plan.</p> <p>Dyersburg Housing Authority continues to provide well-maintained units for the residents and monitors the operations of the developments to ensure that they operate efficiently and effectively.</p> <p>Public housing units in the Walker Court development have been renovated in two phases with a third and final phase underway with the use of the Capital Fund Grant program. Improvements to the units included the complete renovation of the bathrooms and kitchens, installation of new heating and air conditioning systems, upgraded electrical, new LED light fixtures, new flooring, laundry rooms to provide space for the washing machine and dryer to be placed together in a designated area, installation of new interior and exterior security screen doors.</p> <p>Concerted efforts were made to increase customer satisfaction by providing a drop box for applicants and tenants to return necessary documentation in connection with their housing assistance. A website was designed and launched to provide information about DHA's housing. An online payment feature was added to the website for the ease of paying rent. Separate debit/credit card machines were also installed in the office to receive payments from new tenants as another method for payment transactions.</p> <p>Public housing vacancies have been reduced and occupancy rates have increased in the midst of the COVID-19 pandemic. There have been discussions regarding the development of an elderly housing complex to accommodate the aging population with affordable housing opportunities in our community.</p>

DYERSBURG HOUSING AUTHORITY ANALYSIS

Dyersburg Housing Authority management agrees with the need for additional parking areas. Residents are not allowed to park in the grass, and some of the streets are not conducive for parking. Originally, the developments were built when most families owned one vehicle per household. Currently, most of the families own several vehicles. Management will review the prioritized needs for the developments.
